Vin Lananna will receive golf privileges at River Ridge Golf Course for fundraising purposes as part of his employment. Privileges will include greens fees, driving range and golf cart rental.

#### Hiring Title: Associate Athletic Director / Director of Men's and Women's Track / Cross Country

#### Working Title: Associate Director of Athletics for Olympic Development and Promotions And Director of Track & Field / Cross Country

The working title will appear on business cards, media guide, press releases and all publications from the Athletic Department. The official University of Oregon hiring paperwork will use the hiring title. However, the position title will be changed administratively to the working title in short order.

This position (hereafter, "ASSOCIATE DIRECTOR") reports to the Director of Athletics in all aspects of administering, marketing, coaching, and recruiting for a combined men's and women's track and field / cross country program (hereafter, "PROGRAM"). The ASSOCIATE DIRECTOR is directly responsible for all aspects of the PROGRAM within the guidelines and policies established by the NCAA, Pac-10, and the University of Oregon.

The ASSOCIATE DIRECTOR possesses the autonomy for hiring and retaining staff and all decision-making that affects the PROGRAM. The ASSOCIATE DIRECTOR is an active member of the administrative staff of the Director of Athletics. The ASSOCIATE DIRECTOR will participate in a variety of high-level department administrative meetings involved in developing and implementing the department's goals and policies. This inclusion would facilitate an eventual transition away from coaching into more of an administrative role in the future if so desired.

### Primary Areas of Responsibility for the ASSOCIATE DIRECTOR

- 1. Provide the leadership, vision, and management necessary to build a successful PROGRAM at the Pac-10, NCAA, and USA national levels.
- 2. Oversee the administration of the University of Oregon's PROGRAM, which will include developing and executing comprehensive plans to:
  - A. Revitalize the sport of track and field in the Eugene community, and, ultimately, the United States.
  - B. Attract major national and international events to the University of Oregon.
  - C. Oversee a renovation and expansion of the track and field facilities at the University of Oregon.
  - D. Hire, mentor, supervise, and evaluate a coaching, administrative, and athletic support staff that facilitates the vision for the PROGRAM.
  - E. Market and promote a PROGRAM that connects the greater community, the athletics department, and the University of Oregon.
  - F. Foster a vibrant Olympic development program in Eugene.
  - G. Assist the Director of Athletics in implementing a comprehensive plan for a successful athletics department as a member of the administrative staff of the Director of Athletics.

### Staffing

The ASSOCIATE DIRECTOR will have the authority to make all final hiring decisions for the PROGRAM's coaches and staff and to oversee all individuals who directly impact the conduct of the PROGRAM. The ASSOCIATE DIRECTOR will conduct a courtesy interview with members of the current track staff to determine whether they fit the needs of the program. All guidelines from the University, Pac-10 Conference, NCAA and State of Oregon will be followed for procedural matters under the guidance of the department's Personnel Director. Positions and some specific areas of responsibility for those individuals are outlined below. Compensation packages will be established at the level necessary to attract and retain the most talented coaching and administrative staff in the country and will contain incentive clauses as necessary to motivate and retain the staff.

#### **Events**

The ASSOCIATE DIRECTOR will have the autonomy to bid on any NCAA, USA Track & Field, or IAAF event necessary for the fulfillment of the vision for the PROGRAM. A successful bid for the 2008 United States Olympic Track and Field Trials is a significant foundation for the PROGRAM's future. The IAAF World Indoor Track and Field Championships is also an important event for the PROGRAM.

#### Facilities

In order to attract these and other important events, renovations to Hayward Field must occur in the near future. The Director of Athletics supports the commission of a master plan for Hayward Field to determine the priority of projects. If it is determined that chief among those renovations is the installation of stadium lighting and a video scoreboard, the Director of Athletics will ask the department's major gifts fund-raisers to move as quickly as possible to obtain the necessary funding. Expansion of the track and field facilities is also important, including the construction of an indoor facility capable of hosting the NCAA, USA, and IAAF World Indoor Championships.

#### **Community Building**

The ASSOCIATE DIRECTOR will have the autonomy to market and promote the PROGRAM within the University, Eugene, Oregon, United States, and international communities as appropriate. The ASSOCIATE DIRECTOR will serve as an ambassador for the PROGRAM at appropriate functions and will receive the support of the athletic department's marketing staff as appropriate, including support for print publications, and radio and television broadcasts. The ASSOCIATE DIRECTOR will have the autonomy to negotiate corporate sponsorships, raise funds, and interact with alumni as appropriate.

#### **Olympic Development of Track and Field**

The University of Oregon is uniquely positioned to help establish the track and field "capital" in the United States where great athletes reside, compete, and promote the sport of track and field as drug-free role models. The ASSOCIATE DIRECTOR will have the autonomy to provide the leadership and vision necessary to work cooperatively with corporate sponsors, USA Track & Field, the IAAF, and the United States Olympic Committee as appropriate to fulfill that unparalleled potential.
